4. Processing locations and methods and data retention times

The data collected from the website are processed at the Data Controller's headquarters.

Processing will take place exclusively using hard copy means.

Data are retained for the time strictly necessary to the purpose for which they are processed ("storage limitation principle", Art.5, EU Regulation 2016/679), and in any case no more than a period of 1 year from their collection. Subsequently, for statistical purposes only, aggregate data from visits are stored, without any possibility to trace the personal data of the data subjects.

In any case, the Data Controller implements rules that prevent permanent data retention and therefore, limits the retention time according to the principle of minimizing data processing.

Data may then only be stored in compliance with specific legal obligations.



5. Authorised subjects, data processors and data communication

Your data will be processed exclusively by the Data Controller through specifically trained staff.

The data collected can be provided, in the event of lawful request, solely in the cases envisaged by law, by the Legal Authority.

7. Data subject's rights

- g. (Art. 21 Regulation EU 679/2016 GDPR) opposing processing.
